### Facility Policies

1. All rental fees must be paid in full prior to the event and should be made in the form of cash or check.
2. Additional fees for extra services such as cleaning, set up, break down, maintenance, or repair will be mutually agreed upon prior to signing this agreement.
3. All advertising for event must be approved by CES management prior to event.
4. CES's Courtside Café and CES vending machines will be the only available food or drink options during normal CES operating hours.  
**NOTE: If event operator does not monitor teams and fans from bringing in outside food/drink, you will forfeit the damage/clean up deposit.**
5. Appropriate footwear is required for all participants. No hard or black soled shoes permitted on the competition courts.
6. Any in arena advertising has to be discussed and approved by CES management.
7. All groups must furnish proof of liability insurance of not less than \$1 million dollars for the rental date(s) listed on the facility agreement.
8. **All rental groups agree to hold CES harmless during the rental period and will provide CES with said Certificate of Liability naming CES as additional insured immediately upon execution of rental contract.**
9. CES is not responsible for ancillary personnel such as referees, trainers, security, etc.
10. Doors open and facility starts billing thirty (30) minutes prior to start time.
11. A Tournament Representative must be present at all times during event.
12. All outside vendors or selling of merchandise or services during the event must be approved by CES prior to the event.
